### 18. Planning Consent & Project Timescale of Development

Councillor N Jacques enquired if a letter could be sent to the developer of “The Orchard” development on Queen Street, to ask when the project is likely to re-commence and also if they would be so kind to tidy up the dormant site. It would appear that rubbish and bags of dog excrement are being thrown onto the site, making it unpleasant for local residents and pedestrians walking past. The unevenness of the public footpath to the site was also noted as being hazardous and an eyesore. It was also observed that a development currently being undertaken on a property on Brigg Road has resulted in contractors vehicles parking onto the public footpath, resulting in severe damage occurring to the path.
