

**BARTON - UPON - HUMBER TOWN COUNCIL**  
**MINUTES of an ORDINARY MEETING HELD in the COUNCIL CHAMBER, BAYSGARTH**  
**HOUSE, BARTON, on WEDNESDAY 7 DECEMBER 2016 COMMENCING at 7.00 p.m.**

Prior to the meeting commencing, Mr D Ettridge of Ettridge Architecture and Mr D Dent (Developer) spoke about a proposed scheme for the former Coach and Horses Public House and land to the rear located on the High Street, Barton. Mr Ettridge explained the former public house would be converted into 6 flats and there would be 12 dwellings on land to the rear of the property. There would be 2 parking spaces per dwelling, 4 spaces allocated to the 6 flats with the addition of visitor parking. There would be a one-way vehicular system in/out of the development for safety reasons and the properties would be built to a high specification to the 'Lifetime Home Standards'. This means that each house can easily be converted to housing a lift to the first floor and be wheelchair friendly etc. He felt the development would be an asset to the town and retain a historical building of importance in the town centre. The development would take approximately 3 years to build and complete.

Members of the town council asked questions about the development proposals. The addition of security gating to the complex was muted together with concerns regarding parking availability for each property. Generally, the development was welcomed and had been discussed at the Planning Committee meeting of the town council held on 5 December 2016.

The Chairman Councillor A Todd together with Members of the town council thanked Mr Ettridge and Mr Dent for their informative talk. Mr Ettridge and Mr Dent then left the meeting.

**(b) Applications by Members for Dispensations Previously Submitted**

It is noted that Ward Members and Town Councillors J P Vickers and K Vickers present had previously submitted a "Code of Conduct Dispensation Request" to the Town Clerk. The Clerk had granted dispensation for both members to remain, speak and vote regarding the North Lincolnshire Council submission for outline planning application PA/2016/1490 for proposals to develop land off Ferriby Road, Barton. Period of dispensation granted up to & including the 10 May 2017 (Annual Meeting of Barton-upon-Humber Town Council).

190. **Adjourned Meeting**

The Chairman sought resolution from members present for the meeting to be temporarily suspended to let Mr Paul Chapman representing the Barton Civic Society and the Top Field Action Group to speak about planning application PA/2016/1490 and for agenda item 14 to be brought forward for discussion.

**Resolved** it was agreed to let Mr Paul Chapman speak about Planning Application PA/2016/1490. and for agenda item 14 to be brought forward for discussion.

Mr Chapman gave appraisal of the commercial and residential property proposals for the 'top field' site within the North Lincolnshire Council planning application PA/2016/1490. He stated a firm "no" to the proposals and referred to the North Lincolnshire Council consultation held at The Assembly Rooms, a petition against the planning application and the objections raised upon the North Lincolnshire Council planning website from local residents. Also the objection put forward by the town council, the CPRE and local MP Mr Martin Vickers to the outline proposals. He felt it would be a loss of green open space for outdoor pursuits, have a detrimental impact upon the environment, utilities, drainage, traffic volume and parking. He felt there were inconsistencies in the local plan. He understood that a more detailed planning application was in the pipeline to be submitted and that if North Lincolnshire Council sold the land, the town would only benefit from a fraction from the sale of it. He commented that he wished for the town council to secure this land as open space. He concluded that he felt the outline planning application was not legal, not democratic and not wanted.

The Chairman Councillor A Todd thanked Mr Chapman for his informative talk and re-opened the meeting.

191. **Barton Town Council requests North Lincolnshire Council to withdraw its' plans to develop the site known as the top field, supports the initiative by local residents to have it designated as a town green and seeks views from residents on how to improve it as a public green space**

Councillor N Jacques proposed the above motion, which consists of three parts. For North Lincolnshire Council to withdraw its' plans to develop the site as per the petition objecting to this and other local residents objecting to the application. To retain the land as a public open space, the impact the development would have on the town he felt would harm and destroy the town centre and the traffic problems that would be incurred. Secondly, for the town green to be considered by the town council and thirdly to obtain the views from residents on usage of the public green space.

Councillor J P Vickers proposed an amendment to Councillor N Jacques proposal above, that “Barton Town Council calls upon NLC or any future developer to acknowledge public opinion with over 300 written objections to NLC planning department and a 1200 strong signed petition and withdraw planning application PA/2016/1490 and designate the open space known as top field as a village green. We further believe a full consultation should be undertaken to gauge residents’ views of protecting other green spaces in Barton like millennium wood, Tofts Road park, Dam Road and Butts Road play area”.

Councillor Mr J Oxley commented on the locality, dog walking space, traffic volume, schools, doctors, dentists etc regarding the outline planning application submitted. Councillor C Ulliott reiterated that the town council had objected to the application at the planning committee meeting held on 3 October, endorsed it at an ordinary meeting of the town council on 5 October 2016, it has been opposed by local MP Martin Vickers and the Ward Members of North Lincolnshire Council. Councillor N Jacques commented that he did not agree with Councillor J P Vickers amendment to his proposal as he felt it was a watered down version. However, Councillor J P Vickers stood firm over the proposed amendment he had made.

The Chairman, Councillor A Todd requested a recorded vote, firstly for the amendment to the original proposal put forward. This was seconded by Councillor K Vickers. That “Barton Town Council calls upon NLC or any future developer to acknowledge public opinion with over 300 written objections to NLC planning department and a 1200 strong signed petition and withdraw planning application PA/2016/1490 and designate the open space known as top field as a village green. We further believe a full consultation should be undertaken to gauge residents’ views of protecting other green spaces in Barton like millennium wood, Tofts Road park, Dam Road and Butts Road play area”. In favour of the amendment were Councillors Mrs A Clark, F Coulosey, Mrs J Mason, Mrs J Oxley, Mr J Oxley, N Pinchbeck, C Ulliott, J P Vickers, K Vickers, Ms J Warton, I Welch and D Yellowley.

A recorded vote was then taken for the original proposal put forward by Councillor N Jacques and seconded by Councillor Mrs W Witter that “Barton Town Council requests North Lincolnshire Council to withdraw its’ plans to develop the site known as the top field, supports the initiative by local residents to have it designated as a town green and seeks views from residents on how to improve it as a public green space” In favour of the original proposal were Councillors N Jacques and W Witter.

In light of the majority voting for the amendment to the original proposal, the Chairman Councillor A Todd requested a vote to be taken for “Barton Town Council calls upon NLC or any future developer to acknowledge public opinion with over 300 written objections to NLC planning department and a 1200 strong signed petition and withdraw planning application PA/2016/1490 and designate the open space known as top field as a village green. We further believe a full consultation should be undertaken to gauge residents’ views of protecting other green spaces in Barton like millennium wood, Tofts Road park, Dam Road and Butts Road play area”. All members present then voted in favour of the amendment to be carried.

**Resolved** Barton Town Council calls upon NLC or any future developer to acknowledge public opinion with over 300 written objections to NLC planning department and a 1200 strong signed petition and withdraw planning application PA/2016/1490 and designate the open space known as top field as a village green. We further believe a full consultation should be undertaken to gauge residents’ views of protecting other green spaces in Barton like millennium wood, Tofts Road park, Dam Road and Butts Road play area. North Lincolnshire Council to be notified of this in writing.

**Resolved** that Councillor Ms J Warton locate which school the signs have come from and ask what they wish to do with them.

Councillor N Jacques commented that the planter looks a little lost now it is in-situ and asked if further planters could be purchased and located adjacent to it. 196. **Matters of Report Arising**

(a) **Planning Committee Meeting held 5 December 2016**

Councillor Mrs W Witter gave a full appraisal of the meeting held, commenting on the recent volume of planning applications received. Whilst the committee had previously proposed to review the Local Plan at this meeting, it had been put on hold due to the extensive volume of plans the town council had to comment upon, which she stated several were of great impact upon the town. This included the infrastructure, drainage, flooding concerns, highway and road safety issues and the lack of additional schools, health centre and services for an expanding town. At the same time, a plan had been submitted that was exciting as a new build with a futuristic design.

Councillor N Jacques reported that whilst 560 new houses were stated for the town in the North Lincolnshire Council Housing and Employment Land Allocations Development Plan, all but 70 were deemed to be on the Falkland Way site. All agreed this would place a strain on services in the town.

(b) **Environment Committee Meeting held 21 November 2016**

Councillor N Jacques requested that the Finance & General Purposes Committee look into three litter bins to be re-located in the town. Councillor J P Vickers commented that the Barton Regeneration Group were currently looking into this matter.

202. **Meeting held with The Assembly Rooms Leaseholder on 30 November 2016**

Councillor Mrs W Witter gave appraisal of the meeting held highlighting some of the key issues discussed. These included review of the lease and under-lease, emergency contact for out of hours, a business plan, partnership agreement, maintenance and capital expenditure for the building, a Safer Neighbourhoods inspection, roles and responsibilities of both the town council and the lease holders. Dampness in the walls of the town council offices was muted and replacement of a fire-door (previously agreed by the town council) was to be undertaken. An up-dated structural survey to be undertaken by CHAMP Ltd, match-funding of finance provision and tenancy agreements were also discussed.

It was reported that CHAMP Ltd were requesting a 10% increase from the town council for the under-lease of the town council offices in 2017. It was also stated that CHAMP were required to pay the town council £1 per year for lease of The Assembly Rooms in accordance with the lease agreement. Financial support to CHAMP from the town council was discussed together with future meetings with CHAMP and the best format to do this. It was suggested that a member of the town council attending this meeting, meet with CHAMP the next time with alternative members of the town council.

The merits of leasing The Assembly Rooms to CHAMP were stated by Councillor K Vickers. He commented that a new bar area had been installed with other improvement works, making it better for community use. It was agreed and

**Resolved** the Finance & General Purposes Committee further discuss this matter.

203. **Reports from North Lincolnshire Council Representatives**

(a) **Resurfacing Work**

Councillor K Vickers reported that the Market Place had been resurfaced but the contractor undertaking this has done a poor job. As a result, the work would be re-done shortly. It was also stated that the public footpaths on High Street and Queen Street would be re-surfaced shortly and dog waste bins were reported to be overflowing due to miss use by some dog owners.
