(a) **<u>Planning Applications</u>**

- (1) <u>PA/2017/100 Truelove Property & Construction Ltd (Mr Douglas Hill)</u> Planning permission to erect 3 detached dwellings (plots 7,8 and 9) with associated infrastructure (amendments to previously approved application PA/2003/1575 for 5 dwellings, plots 17-21) at plots 7,8 and 9 on land at St Chad's Way, Barton (Comment: the town council support the concerns raised by several residents' of Pine Park (water course, flood risk issues, ground levels and location for a pumping station). In light of this, the town council require North Lincolnshire Council's comments regarding these issues);

However, the town council have no objection in principle to the change of use of the premises themselves);
- (5) <u>PA/2017/162 Mr Gregory</u> Planning permission to construct a new vehicular access from Pasture Road and erection of 'ball catching net' behind goal at northern end of Barton Town Football Ground, Marsh Lane, Barton (No comment or objection);
