- (1) <u>PA/2018/1714 Mr Mark Bell</u> Notice of intention to fell a Horse Chestnut tree within Barton-upon-Humber Conservation Area at Baysgarth Park, Brigg Road, Barton (Comment: Clarification is required regarding this application. The applicant states he wishes to trim back the tree, whilst North Lincolnshire Council state it is "notice of intention to fell" the tree. In light of this, the town council have no objection for the tree to be pruned but there is no justification given to fell the tree. If the tree is to be felled, then this would be objected to);
- (2) PA/2018/1835 Mrs H Green Application to fell 2 Horse Chestnut trees, identified as T1 and T2 and subject to Tree Preservation (Ferriby Road, Barton-upon-Humber) Order 1990 at 39 Ferriby Road, Barton (According to the 'Arboricultural Safety Report' provided with the application, there are reasons given to fell T1. However, as tree T2 is stated as "the mature Horse Chestnut T2 is a much better specimen and overall is in a good structural and physiological condition", then the town council object to tree T2 being felled);
- (3) <u>PA/2018/1858 Mr & Mrs M Wilson</u> Planning permission to erect a first floor extension at 1 Summerdale, Barton (Comment: No objection but the immediate neighbouring property owners do not appear to have been notified of this planning application);
- (4) <u>PA/2018/ 1855 Tradeline Group (Mr John Crow)</u> Planning permission to erect two garage buildings and a porch at Haven House, Waterside Road, Barton (No comment or objection).
