(a) **<u>Planning Applications</u>**

<u>Resolved</u> that the comments as stated, be made to North Lincolnshire Council on the following Planning Applications:

- Public Notice 2-3-2021 Mrs Carlene Norbury-Welch t/a Carlsbrew Street Trading Consent Grant for hot and cold drinks, ice cream savoury and sweet snacks. Monday to Sunday 10:00 hrs to 17:00 hrs at the Car Park, Humber Bridge Park, Waterside Road, Barton; (Comment: No objections).
- (2) <u>PA/2021/586 Koscikiewicz</u> Application to fell an Ash tree and prune a Sycamore tree within and protected by A1 of the Tree Preservation (Barton Upon Humber) Order 1955 at 4 The Bridges, Barton; (Comment: Committee asked for a condition to re-plant a tree if felling a tree and no objections to the application).
