- b) PA/2023/1426 Planning permission to erect 74 dwellings including associated garages, access roads & public open space to land off Ferry Road, Barrow Upon Humber Committee comments there will be significant pressure on the towns GP and Dental Surgeries as well the Secondary School. It is noted that NHS England have requested S106 funding from this development if approved. Committee supports the application from NHS England.
